# UTAH COMMUNICATIONS AUTHORITY ACT

### Utah Code Ann. 63H-7A-207 PUBLIC SAFETY ADVISORY COMMITTEE

- This committee has 15 members as follows:
  - one representative from an association that represents fire chiefs in the state
  - one representative from an association that represents police chiefs in the state
  - one representative from an association that represents sheriffs in the state
  - one representative from an association that represents emergency medical service personnel in the state
  - a member of law enforcement from a county o the first or second class
  - a member of law enforcement from a county of the third or fourth class
  - a member of law enforcement from a county of the fifth or sixth class
  - one individual from a fire department within a county of the first or second class
  - one individual from a fire department within a county of the third or fourth class
  - one individual from a fire department within a county of the fifth or sixth class
  - one individual from the public safety communications industry
  - The commissioner of public safety or the commissioner's designee
  - The executive director of UDOT or designee
  - The chair of the PSAP Advisory Committee
  - An individual nominated by the representatives of tribal governments

Technically, until these individuals formally resign from this committee, their term expires, or in the case of UDOT, a new designee is appointed, they remain members of the committee.

\*\*This vacancy results from Tom Ross formally resigning from this committee. Chief Ross was a member of law enforcement from a county of the first or second class and a qualifying person can be nominated to fill that position for the remainder of his term or the seat can be filled for a term beginning June 12, 2021.

  - a PSAP from a county of the 5th or 6th class
  - a member from the telecommunications industry

### Utah Code Ann. 63H-7A-207 AND -208 General Provisions

- UCA's Governing Board appoints most members to the Advisory Committees. Practice has been to do so based upon nominations from the represented groups or elsewhere if eligible person is nominated.
- Where a person is permitted a designee, UCA requests a written designation to establish authority.
- Terms (with the exception of  $\frac{1}{2}$  of the original terms) are for 4 years.
- Can only serve two consecutive terms.
- Chair and Vice Chair should be selected every January.
- Committees have to meet at least 4 meetings per year.
- Chair may call special meetings or a majority of members can call a special meeting.
- Majority of members constitutes a quorum and a majority vote of the members present constitutes an action of the committee.
- The chair of each committee is a non-voting member of UCA's Governing Board.

#### Public Safety Advisory Committee

"The public safety advisory committee shall, on behalf of stakeholders, make recommendations to the director and the board regarding: (a) the authority operations and policies; (b) the radio network division and interoperability division strategic plans; (c) the operation, maintenance, and capital development of and access to the public safety communications network; (d) the authority's administrative rules relative to the radio network division and interoperability division; and (e) how to solve stakeholder interoperability problems."

#### **PSAP** Advisory Committee

"The PSAP advisory committee shall, on behalf of stakeholders, make recommendations to the director and the board regarding: (a) the authority operations and policies; (b) the 911 division and interoperability division strategic plans; (c) the operation, maintenance, and capital development of the public safety communications network; (d) the authority's administrative rules relative to the 911 division and the interoperability division; and (e) the development of minimum standards and best practices as described in Subsection 63H-7a-302(1)(a)."

## Advisory Committee Meetings

- Not subject to OPMA but shall:
  - At least 24 hours before a committee meeting, post a notice of the meeting, with a meeting agenda, on UCA's website;
  - Within 10 days after a committee meeting, post to UCA's website the audio and draft minutes of the meeting; and
  - Within three days after the committee approves minutes of a committee meeting, post the approved minutes to UCA's website.
- UCA's Babbi Hill will help with the posting of the documents, but the committees' vice chairs are responsible for preparing agendas, minutes, and recordings (or at least coordinating with Babbi to ensure a recording can be made utilizing UCA's equipment).
- UCA is also happy to provide conference rooms, phone lines, and/or Webex meeting means as available.
