Quin: UCA's decision and money available. Justin.

Justin: Who will be doing the program for the VHF side?

Quin: Each agency will have access to the program VHF side. Will you need software to program the VHF. Quin will find the answer.

Justin: Wildland fire, who builds loads. UCA is happy to do it.

Scott: Clarity on simulcast. Design the system if you lose connectivity from PSAP to the core. What's the redundancy to get back to the core?

Quin: UCA has hundreds of backhaul paths. PSAP should have an over-the-air backup. PSAP should check into control stations as backups. (Mobile Radio for L3H)

Alicia, traditionally the chair has been moved up from the vice chair, is currently Neil.

Justin agrees with Alicia. Captain Trotta Nominates Neil. Kevin seconds motion—unanimous ya vote.
